


CIVIL LAW

CLERKING - ADMINISTRATION

- Offering substantial knowledge across all of our key practice areas, our team of experienced clerks pride themselves on being approachable, friendly and as accommodating as possible.
- Client care is paramount, and the clerks are extremely conscientious and client-focused.
- Our clerks proactively seek and welcome feedback from their professional clients to monitor and strive to improve the service offered.
- Through regular practice meetings, the clerks ensure that members will be undertaking the work they are passionate about, which is remunerated appropriately, and within their desired locations.
- Regular communication with our solicitors and private clients ensures that diaries are kept up-to-date and that case papers are delivered quickly to allow for the necessary preparation.

CLERKING - FEES

- We have dedicated fee clerks who use designed automated systems to ensure prompt payment of private paying fees, with all cases invoiced within 7 days of completion (unless agreed otherwise with the individual member of Chambers). Our highly experienced fees team and efficient credit control systems ensure prompt payment. We are currently operating at a 50-day billingto-payment period.
- Efficient systems have been implemented to bill legal aid cases, and cases are billed within 48 hours of receiving the relevant documents, with payment within a further 14-21 days. Electronic working has enabled us to improve the efficiency of billing rapidly.
- High-cost cases are identified at an early stage and managed with solicitors and their costs draftsman to ensure cases are well-managed and the members are remunerated as promptly as possible.
- Staff are encouraged to attend relevant webinars the Legal Aid Agency provides to gain greater understanding and knowledge.

TECHNOLOGY

- We offer a cloud-based hosting service that provides secure, data protection-compliant storage facilities.
- Becket Chambers uses LEX diary management software.
 This allows each member to have constant access to their diaries, billing and payment figures, and the ability to run individual reports when required.
- Chambers has eco targets and fully supports paperless working – all members are provided with an Office 365 licence to use on Chambers' server.
- We use a local, outsourced IT support company who can assist with individual members' personal equipment.
- All members and pupils have access to the entire online LexisNexis library and many hard-copy texts.
- As part of our commitment to cyber security, we are proud to be accredited with a Cyber Essentials Certificate of Assurance. This latest accreditation certifies that we have been assessed and comply with the requirements of the Cyber Essentials Scheme.



- Becket Chambers has a main office in Canterbury that is supported by facilities in Brighton Dartford, Kings Hill (Maidstone) and Tunbridge Wells. We have reviewed our premises requirements and fully embraced changes to how we work to keep us flexible in how we deliver our services.
- We are not committed to any long leases. Our main office is located in a modern building which is part of the Kent University Canterbury campus. The site offers free parking and secure electronic entry.
- Multi-use meeting rooms provide optimal conditions for quiet solo working, traditional in-person meetings, or remote meetings and court appearances. They are also suitable for any ADR appointments.





DIVERSITY & EQUALITY

- Becket Chambers is committed to creating a diverse workspace. Everyone receives equal opportunities without regard to race, colour, religion, gender, gender identity or expression, sexual orientation, national origin, genetics, disability, age, or veteran status.
- We have implemented a new action plan to promote and improve diversity and support members and staff.
- Chambers has long-standing links with the local universities. We arrange competitions and advocacy events for law students, as well as supporting the Employability Points Scheme, which rewards students for their active engagement with co-curricular activities, with experiences of work.

- Routine top-up training is offered to members and staff concerning equality and diversity.


CHAMBERS MANAGEMENT


- We believe the most democratic and egalitarian way to run our Chambers is with an elected Management Committee. This committee meets quarterly (as a minimum) and consists of the Senior Clerk and three members of Chambers.
- There is an annual Chambers meeting which all members are required to attend. These meetings are held remotely, and there are no plans to return to in-person meetings.
- Members are encouraged to be involved in the various committees that are set up to assist the Management Committee.

FINANCES

- Members' contributions are calculated based on a fixed monthly rent element of £420 plus 13% of monthly receipts.
- New members have the option of joining on a percentage-only basis of 20% for up to 12 months.
 We have found that this option is particularly helpful to members when starting at a new Chambers and managing their existing financial obligations.
- There is no upfront joining cost, and Chambers premises are secured under a lease, so there are also no associated building costs.
- Fee scales are reviewed with individual members through regular practice meetings.
- Because of the structure of Becket Chambers, members can work flexibly, and no minimum earning level is required.
- We aim to support members to create a working lifestyle that suits them. Chambers has maternity and parental leave policies in place to ensure that members are supported when required.
- Chambers is able to consider hardship requests and offer reduced or zero contributions to help with unplanned financial pressures or family emergencies.

APPLICATIONS

Applications from high-calibre barristers are always considered as Becket Chambers has an active expansion policy. TENANCY:

Tenants are supported in the development of their practices by a proactive clerking team, and each tenant has considerable ability to shape their own career. If you are interested in applying, please send applications to our Senior Clerk, Paul Eaton e: peaton@becket-chambers.co.uk.

Any conversations or applications will be dealt with in strictest confidence.

Once you have submitted an application, this will be reviewed by our Management Committee, who will generally invite you to interview. They will decide whether to make a recommendation to Chambers, which will then be circulated to all members to make a decision democratically.

PUPILLAGE:

Pupils at Becket Chambers are given the opportunity to train in a number of practice areas to find out what they enjoy and excel in. Chambers usually offers up to two funded pupillages per year, and our policy is only to recruit those we consider to be potential future tenants. Becket Chambers recruits pupils via the Bar Council's online portal Pupillage Gateway, and each pupillage is funded in accordance with Bar Council funding requirements. Pupil earnings during the second six are likely to be in excess of £70k pa.

MINI PUPILLAGE:

Chambers offers a limited number of mini-pupillages a year, and applications should be made by sending a CV and cover letter to clerks@becket-chambers.co.uk


