## Private Law (Child Arrangements Programme (CAP))

Sophie is regularly instructed in private law proceedings (CAP) by mothers, fathers or grandparents who, after separation or breakdown of a relationship, are unable to agree how children should be cared for.

Sophie has experience of helping her clients to resolve a wide range of disagreements, including disputes over where a child should live; how contact with each party should be managed; frequency and duration of contact; where it should take place, and whether overnight stays are involved.



But it can also involve questions of whether contact needs to be supervised, or whether direct contact is appropriate – these questions may arise where there have been allegations of domestic violence or abuse, or where there are concerns about one parent alienating a child against the other.

Disagreements may also arise over a child's surname, where they should attend school, and where they should live, if the parent they live with wishes to move to another part of the country, or abroad.

These cases are often linked with matrimonial finance matters, and are frequently emotionally highly charged situations.

Sophie enjoys working closely with her clients to make sure that they feel supported throughout the process, and to help them take an objective view of the situation, based on what is best for the child/ren involved.

She is regularly instructed at the early stages of private law proceedings and remains with cases until the completion of matters at a final hearing. She particularly welcomes instructions under the Direct Public Access scheme, and recommends seeking her advice as early as possible.

Within private law proceedings, there is scope for negotiations between parties. Sophie is also confident in conducting these negotiations, and is often able to propose alternative ways forward to ensure all parties involved are happy with the outcome of proceedings.

## **Divorce & Matrimonial Finance**

Sophie is regularly instructed to deal with financial provision cases following divorce, and acts at all stages of proceedings from FDA through to FDR and final hearings. She has experience of applications for interim remedies as well as cases involving the variation of a final order.

Sophie takes a rigorous approach to assessing and assimilating complex facts and figures in order to prepare each case, and is adept at presenting large amounts of complex information in a straightforward way, getting quickly to the central issues.
